I hereby take the following action for myself, my respective heirs, assigns and legal representatives, successors and assigns: a) I WAIVE, RELEASE, AND FOREVER DISCHARGE from any and all claims or liabilities for death or personal injury or damages of any kind, EXCEPT THAT WHICH IS THE RESULT OF GROSS NEGLIGENCE AND/OR WANTON MISCONDUCT OF MVA AND/OR THE FIELDHOUSE, and all of its affiliated organizations, owners, officers, agents, and employees, which arise out of or relate to my participation in any MVA activity; b) I AGREE NOT TO SUE any of the persons or entities affiliated with MVA or MVP for any of the claims or liabilities that I have waived, released or discharged herein; and c) I INDEMNIFY AND HOLD HARMLESS the persons or entities mentioned above from any claims made or liabilities assessed against them as a result of my actions.
